# Studies in Historical Geography and Cultural Heritage

## **Instructions**

#### I. GENERAL REMARKS

Contributions can be written in German, English, French, Italian, Russian, Serbian, Modern Greek, Bulgarian, Slavo-Macedonian and Turkish.

Manuscripts must be submitted in completely printable condition (by e-mail as an attachment). The word processing program has to be one of the recent versions of WORD (2005 and later).

The font to be used for Latin letters is Century Schoolbook. For Greek text, a Unicode font should be used. For Old Church Slavonic text, the *BukyVede* font should be utilised. No transcriptions of titles should be made. Greek titles should be given in Greek letters, Cyrillic titles in Cyrillic letters etc.

For reasons of costs, non-electronic manuscripts, i.e. typed texts, cannot be accepted.

All submissions should be in the font Century Schoolbook, 12pt, 1,5 spacing, and grouped style. Footnotes should be in the font Century Schoolbook, 10pt, single spacing, and grouped style. All footnotes end with a full stop. The numbers of the footnotes in the main text shall be placed before the full stop.

Documents should contain the title in bold print at the top of the first page and the full author name below. Subheadings should be in bold and centred. Do not use bold script or italics for other purposes than those indicated below.

The footnotes should provide – starting from the first footnote – a shortened quotation of the respective publication (see below for the respective rules), while the complete set of data should be given in a bibliography at the end of the respective article or monograph. In the bibliography every title of a book, series or a journal has to be put in *italics*. The titles of papers are printed in ordinary letters (not italics and no quotation marks).

If a publication was written or edited by several authors, then their names shall be separated by a dash, e.g. B. Graham – C. Nash.

If a publication was edited by one author, (ed.) has to be applied after the surname, if by several authors then (eds.) after the last surname of all authors, e.g. B. Graham (ed.) or B. Graham – C. Nash (eds.)

If a publication was reprinted, this should be stated in brackets and the respective second edition onwards indicated, e.g. Сремски Карловци 1920 (reprint Београд <sup>2</sup>2002).

Abbreviations for "page" (S., p.) or volume (Bd., vol. etc) are not to be used. If only two pages are quoted from the respective publication, then e.g. either 23–24 or 23f. can be used, but has to be consistently applied.

Notes must automatically be numbered consecutively and arranged as footnotes (not endnotes).

Please use always the title of the source as indicated by the modern scholarly edition itself and do provide the number of the volume and the page(s) of the respective edition or only the page(s), if the edition is not structured in several volumes.

If you are quoting a source, which was put online (e.g. the scan of a manuscript) or published entirely in the internet, please do quote the respective link to the source (see below, 7. *Internet*, *Blog Post*).

### III. QUOTATIONS

Quotations in classical languages – in the text or in the notes – are entered without inverted commas. Texts in Latin, Greek and Old Church Slavonic are in normal types. If possible, translations in modern languages should be provided for a better understanding of the respective context of the used sources.

#### IV. GRAPHICS

If illustrations are to be printed with your contribution, we ask you to use colour illustrations only if absolutely necessary. We point out that you are responsible for obtaining the copyright for the pictures in your article and no costs will be covered by the editors or the publishing house.

The following conditions apply to graphics:

Submission in digital form; we only accept digital images with a minimum resolution of 300 dpi (jpg or tif format). Never convert images of a smaller resolution up to 300 dpi.

We do not accept extremely grainy images and scans or digital photographs of scanned publications. Nor can we accept out-of-focus images using digital cameras.
